

Model for the Exercise of the Rights of the Data Subject

I, the undersigned, born in on
hereby exercises its rights under the EU Data Protection Regulation 679/2016.

Right of access - Article 15 GDPR

The undersigned intends to ask for confirmation:

- that personal data concerning him are currently still being processed;
- that personal data concerning him are no longer being processed.

If yes, the undersigned asks:

- the purposes of the processing;
- the categories of personal data in question;
- the recipients or categories of recipients to whom the personal data have been or will be disclosed, in particular if they are recipients in third countries or international organisations;
- where possible, the intended period of retention of personal data or, if this is not possible, the criteria used to determine that period;
- where the data are not collected from the data subject, all available information on their origin;
- whether there is an automated decision-making process, including profiling, and in particular asks for a description of the logic used, as well as the importance and expected consequences of such processing for the data subject.

Right of rectification - Article 16 GDPR

The undersigned intends to ask the Data Controller:

- rectification/updating/supplementation of personal data concerning him/her. This request concerns *(indicate the personal data, data categories or processing referred to)*

Right of cancellation - Art. 17 GDPR

The undersigned intends to ask the Data Controller to delete personal data concerning him/her for one of the following reasons:

- personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
- the data subject withdraws the consent on which the processing is based and if there is no legal basis for the processing;

- the data subject objects to the processing and there is no overriding legitimate reason to proceed with the processing;
 - personal data have been unlawfully processed;
 - personal data must be deleted in order to comply with a legal obligation under the law of the European Union or of the Member State to which the data controller is subject;
 - personal data were collected in connection with the provision of information society services. This request concerns (*indicate the personal data, categories of data or processing referred to*).

Right to restriction of processing - Article 18 GDPR

The undersigned requests the data controller to restrict processing on the grounds that one of the following grounds applies:

- the data subject contests the accuracy of the personal data, for the period necessary for the controller to verify the accuracy of such personal data;
 - the processing is unlawful and the data subject objects to the deletion of the personal data and requests instead that their use be restricted;
 - although the data controller no longer needs them for the purposes of processing, the personal data are necessary for the establishment, exercise or defence of a legal claim;
 - the data subject has objected to the processing, pending verification as to whether the data controller's legitimate reasons prevail over those of the data subject. This request concerns (*indicate the personal data, categories of data or processing operation referred to*)

Right to data portability - Art. 20 GDPR

The Undersigned requests the Controller to receive in a structured, commonly used and machine-readable format the personal data concerning him/her that he/she has provided to a data controller and has the right to transmit such data to another data controller without hindrance from the data controller to whom he/she has provided them if:

- the processing is based on consent, or on a contract, and
- the processing is carried out by automated means.

This request concerns (*indicate the personal data, data categories or processing referred to*).

Right to object - Article 21 GDPR

The data subject has the right to object at any time to the processing of personal data concerning him/her:

- for reasons related to its particular situation;
- for profiling purposes;



- for direct marketing purposes;
- for scientific or historical research purposes or for statistical purposes, unless the processing is necessary for the performance of a task carried out in the public interest.

The undersigned reserves the right to appeal to the judicial authorities or the “Data Protection Authority” if no suitable response is received within 15 days of receipt of this application.
